(a) to (d): Ministry of Tourism under the schemes of “Swadesh Darshan”, “National Mission on Pilgrimage Rejuvenation and Spiritual, Heritage Augmentation Drive (PRASHAD)” and ‘Assistance to Central Agencies for Tourism Infrastructure Development’ provides financial assistance to State Governments/Union Territory Administrations/Central Agencies for development and modernization of tourism infrastructure and facilities in the country, including North-Eastern Region.

The details of projects sanctioned from 2014-15 till date under the Swadesh Darshan, PRASHAD and Assistance to Central Agencies Schemes for development of tourism related infrastructure and facilities at various tourism destinations in the country including North-Eastern Region is given at Annexure.
