REGISTERED CRIMINAL CASES IN NCR

3725. SHRI A.K.P. CHINRAJ:

Will the Minister of HOME AFFAIRS be pleased to state:

(a) the total number of pick-pocket, cell phone missing/ snatching, bike and car thefts complaints being registered in National Capital Territory (NCT) region from 2014 to 2021;

(b) whether any recovery of above said articles have been done so far along with the recovery percentage rate; and

(c) if so, the details of the cases regarding above categories for which only complaint have been received but no FIR has been filed along with the reasons therefor?

(a) and (b): 'Police' and 'Public Order' are State subjects as per the Seventh Schedule to the Constitution of India. However, the details of the cases of pick-pocketing, cell phone snatching, two wheelers and four wheelers thefts registered and recovery made by Delhi Police during the years 2014 to 2021 (upto 30.11.2021) are at annexure.

(c): Delhi Police has informed that they register criminal cases in all complaints disclosing cognizable offence, with an objective that no crime goes unreported.
