#### NABCONS AND NIRD UNDER DDU-GKY

#### 3753. SHRI MADDILA GURUMOORTHY:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) whether NABARD Consultancy Services (NABCONS) and National Institute of Rural Development (NIRD) has hired the staff as per MoU/Mandate;
- (b) if so, the number of staff permitted for full time payroll as per mandate and MoU;
- (c) the details of Mandates/MoUs and Staff details along with PF and ESI details working for Deendayal Upadhyaya Grameen Kaushalya Yojana (DDU-GKY) programme;
- (d) whether the Union Government has released the total sanctioned funds for NABCONS and NIRD; and
- (e) if so, the details of the funds allocated to the respective States?

#### **ANSWER**

### MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SADHVI NIRANJAN JYOTI)

(a) to (c) NABARD Consultancy Services (NABCONS) and National Institute of Rural Development & Panchayati Raj (NIRD&PR) have been engaged by Ministry of Rural Development as Central Technical Support Agency (CTSA) for Deen Dayal Upadhyaya Grameen Kaushalya Yojana (DDU-GKY). No mandate has been provided in DDU-GKY guidelines nor any specific MoU executed for hiring of staff by NABCONS and NIRD&PR for the purpose.
