DEVELOPMENT OF RURAL AREAS UNDER CSR

3807. MS. DIYA KUMARI:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) whether any new initiatives have been taken for equitable development of rural areas under Corporate Social Responsibility (CSR) during the last three years, if so, the details thereof;
- (b) the details of expenditure incurred on rural development under Corporate Social Responsibility during each of the last three years; and
- (c) the specific areas under which these CSR activities have been carried out?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SADHVI NIRANJAN JYOTI)

(a) & (b) As per the information shared by the Ministry of Corporate Affairs (MoCA), a broad framework for Corporate Social Responsibility (CSR) has been provided through Section 135 of the Companies Act 2013 ('Act'), Schedule VII of the Act and Companies (CSR Policy) Rules, 2014. Schedule VII of the Act indicates the activities that can be undertaken by the company as eligible CSR activities. Further, MoCA has clarified that items mentioned in Schedule VII are broad based and must be interpreted liberally to capture the essence of the subject enumerated. Item number (x) of Schedule VII mentions "Rural Development Projects" as eligible CSR activities. On the basis of filing made by companies in the MoCA registry, CSR funds spent by various companies for "Rural Development Projects" under the Act for the financial years 2017-18, 2018-19 and 2019-20 are given below:

Further, the Ministry of Rural Development has leveraged the funds under CSR for the convergence-based schemes such as Saansad Adarsh Gram Yojana (SAGY) and Shyama Prasad Mukherji Rurban Mission (SPMRM) for converging private / corporate investments with the government initiatives for the development of Gram Panchayats/clusters identified under these schemes. The details of expenditure incurred in the clusters of Shyama Prasad Mukherji Rurban Mission (SPMRM) are placed at **Annexure-I**. However, the expenditure incurred under CSR in SAGY is not maintained centrally by this Ministry.

(c) As per the information shared by the Ministry of Corporate Affairs, the CSR activities are carried out in line with the activities indicated in the Schedule VII of the Act and Companies (CSR Policy) Rules, 2014. The same is placed at **Annexure-II**.

Activities that may be included by companies in their CSR policies. Activities relating to:

- 1) eradicating hunger, poverty and malnutrition; promoting health care including preventive health care and sanitation including contribution to the 'Swachh Bharat Kosh' set-up by the Central Government for the promotion of sanitation and making available safe drinking water;
- promoting education, including special education and employment enhancing vocation skills especially among children, women, elderly, and the differently abled and livelihood enhancement projects;
- promoting gender equality and empowering women, setting up homes and hostels for women and orphans; setting up old age homes, day care centres and such other facilities for senior citizens and measures for reducing inequalities faced by socially and economically backward groups;
- ensuring environmental sustainability, ecological balance, protection of flora and fauna, animal welfare, agro forestry, conservation of natural resources and maintaining quality of soil, air and water including contribution to the 'Clean Ganga Fund' set-up by the Central Government for rejuvenation of river Ganga;
- 5) protection of national heritage, art and culture including restoration of buildings and sites of historical importance and works of art; setting up public libraries; promotion and development of traditional arts and handicrafts;
- 6) measures for the benefit of armed forces veterans, war widows and their dependents, Central Armed Police Forces (CAPF) and Central Para Military Forces (CPMF) veterans, and their dependents including widows;
- 7) training to promote rural sports, nationally recognized sports, paralympic sports and Olympic sports;
- 8) contribution to the Prime Minister's National Relief Fund or Prime Minister's Citizen Assistance and Relief in Emergency Situations Fund (PM CARES Fund) any other fund set up by the Central Government for socio-economic development and relief and welfare of the Scheduled Castes, the Scheduled Tribes, other backward classes, minorities and women;
- 9) (a) Contribution to incubators or research and development projects in the field of science, technology, engineering and medicine, funded by the Central Government or State Government or Public Sector Undertaking or any agency of the Central Government or State Government; and

(b) Contributions to public funded Universities; Indian Institute of Technology (IITs); National Laboratories and autonomous bodies established under Department of Atomic Energy (DAE); Department of Biotechnology (DBT); Department of Science and Technology (DST); Department of Pharmaceuticals; Ministry of Ayurveda, Yoga and Naturopathy, Unani, Siddha and Homoeopathy (AYUSH); Ministry of Electronics and Information Technology and other bodies, namely Defense Research and Development Organisation (DRDO); Indian Council of Agricultural Research (ICAR); Indian Council of Medical Research (ICMR) and Council of Scientific and Industrial Research (CSIR), engaged in conducting research in science, technology, engineering and medicine aimed at promoting Sustainable Development Goals (SDGs).

- 10) Rural development projects.
- 11) Slum area development.

Explanation- For the purpose of this item, the term 'slum area' shall mean any area declared as such by the Central Government or any State Government or any other competent authority under any law for the time being in force.

12) Disaster management, including relief, rehabilitation and reconstruction activities.
