### 3876. SHRIMATI RITA BAHUGUNA JOSHI:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the details of the wages paid to the workers under Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) in different States;
- (b) whether States, in addition to the Central funds are also contributing from its funds towards the wages paid to the workers under MGNREGS; and
- (c) if so, the details thereof and the quantum of funds contributed towards it?

(a) State/UT-wise details of fund released for wage component under Mahatma Gandhi National Rural Employment Guarantee Scheme (Mahatma Gandhi NREGS) in current financial year 2021-22 (as on 16.12.2021) is given at **Annexure**.

(b) & (c) Central Government provides 100% wage payment as per the notified wage rate applicable to the beneficiaries under Mahatma Gandhi NREGS. However, State may also pay wages over and above the notified wage rate. Currently, State of Jharkhand and Odisha are making payment over and above the notified wage rate in some areas of the State.
