Will the Minister of AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण मंत्री be pleased to state:

- (a) whether the Government has collaborated with a private bank for National Agriculture Market (eNAM) to enable digital collections and settlement of funds to various eNAM beneficiaries in the country, if so, the details thereof;
- (b) the number of registered farmers and traders on eNAM and who have benefitted from the digital marketplace;
- (c) the total value of agri-produce traded on eNAM so far since its inception;
- (d) the achievements made by the Small Farmers Agri-Business Consortium (SFAC) set up as the nodal implementing agency by the Ministry since its inception;
- (e) whether the SFAC is implementing Central Sector Scheme (CSS) on "Formation & Promotion of 10000 FPOs" across the country, if so, the details thereof; and
- (f) the other steps being taken by the Government for development of agriculture and welfare of farmers in Bolangir constituency of Odisha?

ANSWER

MINISTER OF AGRICULTURE AND FARMERS WELFARE

(a): Small Farmers Agribusiness Consortium(SFAC) under aegis of Ministry of Agriculture & Farmers Welfare, Government of India has empanelled banks viz. Axis Bank Limited, Kotak Mahindra Bank Limited, HDFC Bank, Indusind Bank Limited & ICICI Bank for provisioning of payment & settlement services for National Agriculture

Market (eNAM) transactions. The empanelment of above mentioned banks enable collections and settlement of funds to various eNAM registered beneficiaries across the country.

- (b): As on 31st October 2021, a total of 1.7 crore farmers and 1.98 lakh traders have registered themselves and many of them have benefitted from National Agriculture Market(e-NAM).
- (c): As on 31st October, 2021, the total value of Agri-produce traded on e-NAM is worth Rs. Rs. 1,50,664 Crore.
- (d) & (e): SFAC is one of the Implementing Agencies under the Central Sector Scheme for formation and promotion of 10,000 FPOs. Under the Scheme, SFAC has been allotted target for formation and promotion of 566 FPOs during 2020-21, out of which 442 FPOs have been registered so far.

Further, SFAC is also implementing schemes of Venture Capital Assistance(VCA) and National Agriculture Market (e-NAM).

(f): As informed by Govt. of Odisha, the major schemes are implemented in the Bolangir District of Odisha as at Annexure-I.
