(a): Ministry of Railways have delegated powers to Zonal Railways in March 2015 to increase rate of platform tickets beyond ₹ 10 to regulate rush in platforms during specific occasions like mela etc. Accordingly, Railways exercise these powers as per their requirements. Revenue generated from sale of platform tickets during last two years and current year upto September-2021, is as under:

(b): Passenger fare is highly subsidized and revenue generated from passenger fare is less than the operating cost. Revenue foregone due to concessions on passenger fare to various categories of passengers during the financial year 2019-20 and 2020-21 is ₹ 2059 crore and ₹ 38 crore respectively. Total
