- (a) whether the construction of several railway-over-bridges (ROBs) and railway-under-bridge(RUBs) in Maharashtra is still pending;
- (b) if so, details of these pending rail projects route-wise and location-wise;
- (c) the main reasons for delay in these rail projects; and
- (d) the time by which these pending rail projects are likely to be completed alongwith the route-wise details thereof?

(a) to (d): As on Oct'2021, 158 Road over Bridges (ROBs) and 249 Road under Bridges (RUBs) have been sanctioned by Ministry of Railways in Maharashtra. Out of 158 ROBs, Railway portion have been completed in 13 and work is in progress in other 65 ROBs. Remaining 80 works are at planning stage like finalization of alignment and preparation of estimate etc. Similarly, out of 249 RUBs, 63 works are in progress. Remaining 186 works are at planning stage like finalization of alignment and preparation of estimate etc.

Section-wise details are appended.

Construction of ROB/RUBs depends upon the consent of State Government for closure of LCs and cost sharing, wherever applicable, availability of encroachment free land for approach roads, technical feasibility, shifting of utilities, allocation of adequate funds by State agencies, public support etc. therefore, it is not feasible to fix timelines for completion of these ROB/RUBs.
