- (d) the details and number of mandis/temporary purchase centres/aggregation points that have operated in Assam during rabi and kharif harvest seasons of 2020-21 and 2021-22;
- (e) whether the Government has data on which states/regions the food grains distributed through PDS in Assam are procured from and if so, the details thereof:
- (f) whether the Government has taken steps to implement decentralized procurement of food grains in Assam; and
- (g) if so, the details thereof; if not, reasons therefor?
