(a): The Grant-in-Aid released during 2017-18 to 2020-21 under the National Child Labour Project (NCLP) Scheme, State-wise including Maharashtra is at Annexure-I.

(b): The details of beneficiaries of PENCIL (Platform for Effective Enforcement for No Child Labour) under the NCLP scheme is at Annexure-II.

(c): The total number of web visits as on 24.11.2021 on PENCiL (Platform for Effective Enforcement for No Child Labour) by PENCiL registered users is 85,23,763 .

(d): As per data available on PENCiL portal as on 24.11.2021, 1151 number of adolescents in the age bracket of 14 to 18 years have been withdrawn from work.

(e): The Ministry carries out public awareness about child labour through its website and various social media handles. In addition, District Project Society also carries out the awareness programme for which funds are provided by Ministry of Labour & Employment.
