SOLID WASTE MANAGEMENT UNDER SBM

NO. 731. DR. KALANIDHI VEERASWAMY :

Will the Minister of State for HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) the features of the Solid Waste Management under Swachh Bharat Mission (SBM);**
- (b) the details of funds sanctioned, allocated and utilized under this mission within Tamil Nadu during the last three years and the current year;**
- (c) whether the Government covers dump yard sites under Solid Waste Management and if so, the details of the funds shared by the Government;**
- (d) whether the Government has proposed to cover Kodunagaiyur dump site which has grown to a formidable size due to garbage being dumped by Chennai Corporation and became a health menace causing respiratory troubles, skin problems and allergies to the common people; and**
- (e) if so, the details thereof and if not, the reasons therefor?**

(a): The features of Swachh Bharat Mission-Urban (SBM-U) 2.0, launched on 01st October, 2021, are :

- (i). Sustainable Solid Waste Management (SWM),**

- (ii). Sustainable sanitation and treatment of used water,**
- (iii). Awareness creation with large scale citizen outreach to create 'Jan Andolan' and institutionalise 'Swachh' behaviour,**
- (iv). Create institutional capacity to effectively implement pragmatic interventions to achieve Mission objectives.**

(b): Details of funds sanctioned, allocated and utilized by Tamil Nadu during the last three years and the current year under SBM-U is annexed.

(c): Remediation of dumpsites, including all legacy dumpsites, is covered as an admissible element for funding under SBM-U 2.0. SBM-U 2.0 has been launched on 1st October, 2021. Under SBM-U, from 02.10.2014 to 31.03.2021, an amount of ₹6,373.54 Crore has been released for SWM, including for dumpsite remediation, to all States/ Union Territories (UTs).

(d) and (e): A proposal for Central Share (CS) funding for Kodunagaiyur dump site project at a total cost of ₹642 Crore has been received by the Government. This project would be considered for funding under SBM-U 2.0 provided the proposal is submitted by Government of Tamil Nadu, fulfilling all the conditions stipulated in the SBM-U 2.0 Operational Guidelines for such funding.
