STATUS OF PROJECTS UNDER SMART CITY MISSION

NO. 779. SHRI MOHANBHAI KALYANJI KUNDARIYA:

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) the detailed status of projects under Smart City Mission (SCM) in Rajkot, project-wise;**
- (b) the funds allocated and utilised till date, project-wise;**
- (c) whether the Government has met its agenda for the projects or faced any bottlenecks in process of implementation and if so, the details thereof;**
- (d) the timeline of implementation of the projects, State-wise; and**
- (e) whether more cities are being considered under SCM in Gujarat and if so, the details thereof?**

(a): Government of India launched the Smart Cities Mission (SCM) on 25 June 2015. 100 Smart cities have been selected through 4 rounds of competition from January 2016 to June 2018. The city of Rajkot was selected for development as a Smart City in Round-3 in June, 2017. The status of Smart City projects of Rajkot is given below: -

(b): As on 12 November, 2021, Government of India has released ₹ 294 crore for Rajkot Smart City, out of which the city has utilised ₹ 244 crore (83%).

(c): As on 12 November 2021, the 100 Smart Cities have tendered out 6,452 projects worth ₹ 1,84,998 crore; out of which work orders have been issued in 5,809 projects worth ₹ 1,56,571 crore; out of these, 3,131 projects worth ₹ 53,175 crore have been completed. In Rajkot Smart City, out of 94 projects worth ₹ 3751.70 crore, 68 projects (72%) worth ₹ 2,006.71 crore (53%) have either been completed or are at various stages of implementation.

(d): The period of implementation of SCM has been extended upto June 2023 and all Smart Cities, including Rajkot, are expected to complete their projects within the stipulated time.

(e): Presently, there is no such proposal under consideration of the Government.
