NO. 868. SHRI BHAGIRATH CHOUDHARY:

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) the names of the cities selected under Smart City Mission in the State of Rajasthan, phase-wise;**
- (b) the details of the budgetary allocation under the said Mission, State-wise;**
- (c) whether necessary funds have been allocated to Ajmer to develop as a smart city under the said Mission;**
- (d) if so, the details of the fund allocated and utilised so far;**
- (e) whether the Smart City Project in Ajmer city is in a position to be completed on time; and**
- (f) if so, the details thereof and if not, the action taken against the officials responsible for the delay including the efforts are being made by the Government for the same and the details of the progress report of the said work?**

(a) to (f): Government of India launched the Smart Cities Mission (SCM) on 25 June 2015. 100 Smart cities have been selected through 4 rounds of competition from January 2016 to June 2018. 4 cities in the State of Rajasthan i.e., Ajmer, Jaipur, Kota & Udaipur have been selected for development as Smart Cities. Smart City-wise details of selection, progress of projects, funds released by Central Government & utilization thereof are given in Annexure-I.

The period of implementation of SCM has been extended upto June 2023 and all Smart Cities, including Ajmer, are expected to complete their projects within the stipulated time.
