SETTING UP OF DAIRIES

Will the Minister of FISHERIES, ANIMAL HUSBANDRY AND DAIRYING

be pleased to state:

- (a) whether the Government is implementing any scheme for providing financial assistance for setting up of dairies in the country and if so, the details and salient features thereof;
- (b) the amount of assistance provided by the Government in various States during each of the last three years and the current year, State/UT-wise;
- (c) whether the Government proposes to impart training to milk producers for equipping them with new techniques in developing dairy sector; and
- (d) if so, the details thereof?

ANSWER

THE MINISTER FOR FISHERIES, ANIMAL HUSBANDRY AND DAIRYING

(a) to (d) A statement is laid on the Table of the House.

STATEMENT REFERRED TO IN REPLY OF LOK SABHA STARRED QUESTION NO. 181 PART (a) TO (d) ON “SETTING UP OF DAIRIES” TO BE ANSWERED ON 15.03.2022.

(a) The Department of Animal Husbandry and Dairying (DAHD) provides financial assistance for setting up of dairies across the country through its following schemes:

1. Dairy processing & Infrastructure Development Fund (DIDF)

The objective of the scheme is creation/ strengthening of Milk Processing & Value Addition Infrastructure for Dairy Co-operative, Multi State Dairy Cooperative, Milk Producer Companies (MPC), National Dairy Development Board (NDDB) and its subsidiaries, registered Self Help Groups (SHGs) and Farmer Producer Organizations (FPOs).

Under this scheme, NABARD raises funds and disburses them as loans to NDDB/ National Cooperative Development Corporation (NCDC) for onward disbursement to the End Borrowers. NDDB has also been allowed to give loans to End Borrowers from its own resources. GOI provides 2.5 % interest subvention for such loans.

Activities supported under this scheme include infrastructure for Milk Processing, Value addition & chilling facilities, Cattle feed/ feed supplement plants, Milk transportation system, Marketing infrastructure, Commodity and Cattle feed godowns, ICT infrastructure, Research and Development (R&D) laboratories & equipment, Renewable energy infrastructure, energy efficiency infrastructure, Pet bottle/ packaging material manufacturing units for dairy purposes, Training centre.

2. National Programme for Dairy Development (NPDD)

The objective of the scheme is creation/ strengthening of infrastructure for production of quality milk, procurement, processing and marketing of milk & milk products.

The scheme has two components:

- i. Component 'A' focuses towards creating/ strengthening of infrastructure for quality milk testing equipment as well as primary chilling facilities with grant-in aid assistance (60:40 Centre and States share & 90:10 for the North Eastern and Himalayan States, 100% Central share for Union Territory). The scheme is implemented through State Implementing Agency i.e. State Cooperative Dairy Federation and State Rural Livelihood Mission
- ii. Component 'B' focus on Strengthening Milk Procurement Infrastructure, Strengthening Processing Infrastructure, Support for Marketing Infrastructure, Support for ICT, Productivity Enhancement – through nutritional interventions, Project Management and Learning & Training & Capacity Building etc. with amalgamation of grant-in aid and loan at subsidized rate of interest (at rate of

1.5%). The scheme is implemented through NDDDB for participating institutions viz. Milk Unions, Multi State Milk Cooperatives, State Milk Federations, Milk Producer Companies

3. **Animal Husbandry Infrastructure Development Fund (AHIDF)**

Animal Husbandry Infrastructure Development Fund (AHIDF) aims to incentivize investments by individual entrepreneurs, private companies, Micro, Small and Medium Scale Enterprises (MSME), Farmers Producers Organizations (FPOs) and non-profit (Section 8) companies for establishment of (i) dairy processing and value addition infrastructure, (ii) meat processing and value addition infrastructure (iii) Animal Feed Plant (iv) Breed improvement technology and Breed multiplication farm.

Under this scheme, interest subvention is provided by GOI at 3% per annum for all Eligible Entities. Credit Guarantee facility is also available upto 25% for MSMEs.

4. **Breed Multiplication Farm under Rashtriya Gokul Mission (RGM):** One of the components of the sub-scheme RGM is to promote establishment of breed multiplication farm. Under the scheme, 50% capital subsidy (maximum upto 2 Crore) is available for the entrepreneur-aggregator (private individuals/ Farmer Producer Organizations (FPOs)/ Farmer Cooperative Organizations (FCOs)/ Self Help Groups (SHGs)/ Joint Liability Groups (JLGs) and non-profit (Section 8) companies and any individual/ organization availing loan facility under Animal Husbandry Infrastructure Development Fund (AHIDF).

Under this component, the project is not only implemented through NDDDB but also the subsidy is released directly to the beneficiary loan account through NDDDB.

5. In addition to above, assistance is also provided for Animal Husbandry and Dairy Development including setting up of dairies under the Rashtriya Krishi Vikas Yojana (RKVY) scheme of Ministry of Agriculture and Farmers Welfare.

The funds are released to State Governments as Grants-in-Aid (60:40 Centre and States share; 90:10 for North Eastern and Himalayan States and 100% Central share for Union Territories) on the basis of projects in Agriculture & allied sectors approved in the State Level Sanctioning Committee Meeting (SLSC) of the states concerned.

(b) The assistance provided under the abovementioned schemes for Dairy Development including Setting up of Dairies is Annexed.

(c) and (d) DAHD is implementing the following schemes under which assistance is provided for orientation/ training programme for Dairying activities:

- i. **Dairy Processing and Infrastructure Development Fund (DIDF):** Interest subvention on loan assistance is provided to End Borrowers for establishment/ construction of training center (complete with civil and other necessary infrastructure) to eligible entities
- ii. **National Programme for Dairy Development (NPDD):** Grant assistance is provided for training and awareness programme to farmers on good hygienic practice & good

manufacturing practice, to milk testers, DCS staff, dairy personnel on plant operations etc.

- iii. **Rashtriya Gokul Mission (RGM):** Funds are released to all States/ Union Territories (UTs) for skill development namely Basic training of Multipurpose Artificial Insemination Technicians for Rural India (MAITRIs), training of existing AI workers and training of professionals etc.
- iv. In addition to above, NDDB conducts the following training programmes for milk producers:
 - i. Training programmes for milk producers at NDDB's training centres and at the milk unions, in which advancements in animal nutrition, green fodder conservation, etc. are demonstrated
 - ii. Clean Milk production for the milk producers
 - iii. Training on Automatic Milk Collection System for dairy cooperatives to increase transparency in village level cooperatives, owned and managed by milk producers
 - iv. Scientific Dairy Animal Management trainings for rural youth interested in dairy entrepreneurship
