(a)to(c) Sacred groves are community conserved land parcels, which usually have a significant religious connotation for protecting the community, and can be notified as Community Conserved Areas under Wildlife(Protection) Act 1972, and Biodiversity Heritage Sites under the Biological Diversity Act, 2002.

The Ministry supports protection and conservation of Sacred groves with a strong emphasis on community involvement and eco-development activities.

The details of funds released for the activities in respect of Sacred Groves in Meghalaya by the Department of Forestsand Environment, Government of Meghalaya are at **Annexure**.

The details of studies undertaken and completed for Sacred groves in Meghalaya are as follows:

- 1. Inventorisation (Growing Stock Assessment) of 40 Nos Sacred Groves
- 2. Phytodiversity and Phytosociological characterisation of 10 Nos Sacred Groves having an area of 216.76 Ha
- 3. Preparation of Management Plans of 12 Nos Sacred Groves
- 4. Boundary Survey for 133 Sacred Groves
