Reservation in Ph.D Programmes at IITs

259. SHRI GIRISH CHANDRA:

Will the Minister of **EDUCATION** be pleased to state:

- (a) whether students from the Scheduled Caste and Scheduled Tribe communities have significantly poor representation and acceptance rate in Ph.D programmes at the Indian Institutes of Technology (IITs) in the country;
- (b) if so, the details thereof during the last five years and the current year, course and category-wise and the reasons therefor; and
- (c) the corrective steps taken/to be taken by the Government in this regard?

(a) to (b): The details of the application received, accepted and acceptance rate of the candidates from the Scheduled Caste (SC) and Scheduled Tribe (ST) communities in Ph.D programmes at the Indian Institutes of Technology (IITs) are as under:-

Some of the reasons for poor representation and acceptance rate in PhD Programmes can be attributed to: (i) High level attrition due to better employment opportunities; (ii) Family reasons for earning after graduation; (iii) Priority towards management and allied subjects by Engineering Graduates; (iv) Self-employment after graduation with soft loan opportunities (Start-ups); (v) Higher salary/income on employment after Graduation vis-a-vis lesser fellowship/scholarship amount for pursuing research programmes etc.

(c): IITs are autonomous institutes governed by the Institutes of Technology Act, 1961 and the Statutes framed there under from time to time. Government has mandated IITs to comply with the statutory provisions of the Central Education Institutes (Reservation in Admission) Act, 2006, as amended from

time to time, for admission of reserved category candidates to various programmes including PhD. IITs duly follow guidelines, statutes, norms and directions issued by Central Government. IITs have taken various steps to fill up the PhD seats for SC/ST Students that include (i) Adherence of guidelines for implementation of reservation policy of the Government; (ii) Age relaxation upto 5 years; (iii) Relaxation in minimum qualifying marks; (iv) Exemption of tuition fee to SC/ST students; (v) Subsidized application fee; (vi) apart from Tuition fee waiver, assistant-ship is extended to SC/ST scholars of the Institute for the sixth year of their PhD programme to ensure that the students do not drop out due to lack of financial resources; (vii) More PhD applicants are shortlisted against the number of reserved category seats available for PhD admission to ensure that enough applicants are available for admission under reserved categories; (viii) wide publicity to attract more applications on various platforms including social media, newspapers, websites, etc.
