Will the Minister of TOURISM be pleased to state:

- (a) the details of Tourism Circuits, Tourism Parks and Rural Tourism Clusters identified by the Government in each State/Union Territory particularly in Jharkhand;**
- (b) whether the Government has received requests/ proposals from State Governments of Jharkhand for inclusion of more such Tourism Circuits/ Parks and Clusters and if so, the details thereof and the response thereto;**
- (c) whether the Government proposes to include Jharkhand as part of the International Tourism Circuit in the country to promote the culture of the States and if so, the details thereof; and**
- (d) the other steps taken by the Government to popularise Tourist Circuits in Jharkhand?**

STATEMENT IN REPLY TO PARTS (a) TO (d) OF LOK SABHA STARRED QUESTION NO. *355 ANSWERED ON 28.03.2022 REGARDING PROPOSAL FROM JHARKHAND TO INCLUDE MORE TOURISM CIRCUITS/PARKS

(a) to (d): The Ministry of Tourism under its 'Swadesh Darshan' and 'Pilgrimage Rejuvenation and Spiritual, Heritage Augmentation Drive (PRASHAD)' schemes provides financial assistance with focus on development of tourism infrastructure in the country including Jharkhand. The projects are identified and sanctioned in consultation with the State Governments/UT Administrations, subject to availability of funds, submission of suitable detailed project reports, adherence to scheme guidelines and utilization of funds released earlier etc. The Ministry of Tourism has revamped its Swadesh Darshan scheme for sanctioning of new projects in the country following a destination and tourist centric approach. The details of the projects sanctioned in 'Swadesh Darshan' scheme under different themes and 'PRASHAD' scheme including Jharkhand is at Annexure I.

The Ministry of Tourism promotes various tourism destinations and products including circuits holistically through its website, social media platforms, events, publicity campaigns, webinar etc. in the international and domestic markets.

Ministry of Rural Development (MoRD) has informed that its Shyama Prasad Mukherji Rurban Mission (SPMRM) focuses on holistic development of clusters and to ensure an optimum level of development, twenty one components have been suggested as desirable for the Cluster development. Among the 21 components, Tourism promotion is one of the major component under which States/UTs has proposed investment both under CGF and Convergence for different activities like beautification of tourist sites, infrastructure development at tourist places, Pilgrimage Development for Tourism, construction of Tourism parks, Heritage development, etc. A total of 103 clusters covering 32 States/UTs (including Jharkhand) have proposed an investment of Rs. 492.35 crore both under CGF and Convergence under Tourism Promotion. The cluster wise investment proposed under Tourism promotion component of SPMRM is at Annexure II. So far the state of Jharkhand is concerned, out of the allocated 15 clusters under SPMRM,

eight clusters have proposed tourism development components with an investment of Rs.14.38 cr. No requests/ proposals from state governments of Jharkhand has been received for inclusion of more such tourism circuits parks and clusters under SPMRM.
