(a) whether the Government has made more than 100 percent increase in the budgetary allocation for Financial Year 2022-23 towards building strong foundations for healthcare system in the country;

(b) if so, the details thereof;

(c) whether the Government has selected/identified some backward districts which need continuous monitoring and extra attention with regard to healthcare infrastructure;

(d) if so, the details thereof; and

(e) the funds allocated for different programmes/ schemes for improvement of healthcare system in the country?

**STATEMENT REFERRED TO IN REPLY TO LOK SABHA  
STARRED QUESTION NO. 436\* FOR 1<sup>ST</sup> APRIL, 2022**

(a) to (d): The Budgetary allocation for the Department of Health and Family Welfare, Ministry of Health and Family Welfare (MoHFW), has been enhanced from Rs. 71,268.77 crore in Budget Estimates (BE) 2021-22 to Rs. 83,000.00 crore in Budget Estimates 2022-23, an increase of Rs. 11,731.23 Crore (16.46%) over the previous year.

The overall budgetary allocation is divided in two sections viz Revenue and Capital, the breakup of which is given below:

As per the above information, there is an increase of 124.51% in the Capital component of the Budget in 2022-23 over previous year's allocation which is earmarked mainly for strengthening of infrastructure for healthcare system in the country. Hospital/Institution/Scheme- wise details of allocation for capital component of the budget in financial years 2021-22 and 2022-23 are given at **Annexure A**.

The increase in capital expenditure is mainly provided under Central Sector Schemes- Pradhan Mantri Swasthya Suraksha Yojana (PMSSY), Pradhan Mantri Ayushman Bharat Health Infrastructure Mission (PM-ABHIM), Central Government Health Scheme (CGHS) and Central Government Hospitals located in Delhi viz Safdarjung Hospital, Dr. RML Hospital, Atal Bihari Vajpayee

Institute of Medical Sciences and Lady Hardinge Medical College & Smt. Sucheta Kripalani Hospital including Kalawati Saran Children's Hospital and autonomous institutions. The budgetary allocation earmarked to central hospitals/institutions are not based on criteria like population/backward area coverage etc., but to strengthen infrastructure and for improving patient care facilities. Besides, infrastructure projects under the Central Sector Schemes of Pradhan Mantri Swasthya Suraksha Yojana (PMSSY) and Pradhan Mantri Ayushman Bharat Health Infrastructure Mission (PM-ABHIM) where substantial increase has been provided are spread over different parts of the country. The details are given at **Annexure B**.

Grant-in-Aid for creation of capital asset is also provided to State/Union Territory (UT) Governments under Centrally Sponsored schemes like, establishment of new medical colleges/upgradation of existing medical colleges and newly added programme like PM-ABHIM etc. States/Union territories are suggested to accord preference to set up medical colleges in underserved areas and aspirational districts where there is no medical college. Further, in the operational guidelines of the scheme - PM-ABHIM, it is suggested to the States and Union Territories for prioritizing and ensuring preferential allocation to aspirational /tribal/Left Wing Extremism (LWB)/Remote /Hill districts.

Against the allocation of Rs.7000 crore (Revenue Section: Rs.5153.13 crore and Capital Section: Rs.1846.87 crore) in Budget Estimates for 2021-22, the Budget Estimates in 2022-23 is Rs.10000 crore (Revenue Section: Rs.5673.13 crore and Capital Section: Rs.4326.87 crore).

In addition, under PM-ABHIM, support is being provided to Central Government Institutions for setting up of Critical Care Hospital Blocks.

#### **PM-Ayushman Bharat Health Infrastructure Mission (PM-ABHIM)**

Under PM-Ayushman Bharat Health Infrastructure Mission (PM-ABHIM), financial and technical support is provided to States/UTs for five components under Centrally Sponsored Scheme Component viz:

1. Support for 17,788 rural Health and Wellness Centres in 7 High Focus States (Bihar, Jharkhand, Odisha, Punjab, Rajasthan, Uttar Pradesh and West Bengal) and 3 North Eastern States (Assam, Manipur and Meghalaya)..
2. Establishing 11,024 urban Health and Wellness Centres in all the States.
3. 3382 Block Public Health Units in 11 High Focus States/UTs (Assam, Bihar, Chhattisgarh, Himachal Pradesh, UT - Jammu and Kashmir, Jharkhand, Madhya Pradesh, Odisha, Rajasthan, Uttar Pradesh and Uttarakhand).
4. Setting up of Integrated Public Health Labs in all the 730 districts.

5. Establishing Critical Care Hospital Blocks in the 602 districts with population of more than 5 lakhs.

As the public health & hospitals is the States' subject, the implementation of the scheme lies under the purview of State/UT Governments. However, in the Operational Guideline of the scheme, it is suggested to the States/UTs for prioritizing and ensuring preferential allocations to be made to the backward/Aspirational / Tribal / Left Wing Extremism (LWE) / Remote / Hill districts. In other districts, such units may be prioritized where critical inputs such as land, etc are readily available. This will further enable to reduce time to care and geographical barriers in such difficult terrains.

Under PM-ABHIM, a provision of Rs 64180 Crore has been made for five years w.e.f. FY 2021-22 to 2025-26 including Centrally Sponsored and Central Sector Component.

### **Human Resources for Health & Medical Education**

The Ministry of Health & Family Welfare administers a Centrally Sponsored Scheme (CSS) for 'Establishment of new Medical Colleges attached with existing district/referral hospitals' with preference to underserved areas and aspirational districts, where there is no existing Government or private medical college.

Under the Scheme (launched in 2014), 157 districts have been approved for establishment of medical colleges in three phases (Phase-I 58, Phase-II 24 and Phase-III 75). Out of 157 sites, 40 are in aspirational districts (*Annexure attached*). The total outlay of the scheme is Rs. 41332.41 Cr, the central share (*90% for NER and Hilly States and 60% for Other States*) amounts to Rs. 26715.84 Cr out of which, an amount of Rs. 20540.21 Cr has been released till now. Out of 157 approved medical colleges, 71 (50 in Phase-I, 08 in Phase-II and 13 in Phase-III) medical colleges are already functional.

The Ministry also administers a Centrally Sponsored Scheme for Up-Gradation of Central/State Government Medical Colleges for increase of MBBS seats in existing medical colleges. Under the scheme of increase of MBBS one time grant of Rs. 1.20 crore per seat is provided for infrastructure and equipment. Till date, 52 Medical Colleges have been approved under the scheme to increase 3495 MBBS seat and Rs. 2451.1 Crore have been released to the State Governments.

Under Phase – I of CSS for increasing PG seats, a total of 72 Government Medical Colleges in 21 States/UTs have been approved under the scheme for increasing 4058 PG Seats. Funds to the tune of Rs.1049.3578 crore have been released under the scheme till date. Under Phase – II of this scheme, 18 Government Medical Colleges have been approved under the scheme for increasing

1872 PG seats till date. Funds to the tune of Rs.740.934 crores have been released under the scheme till date.
