(a) & (b)

(i) Ministry of Ayush has established following hospitals attached to National Institutes of Ayurveda, Naturopathy, Unani, Siddha and Homoeopathy in different states to provide system specific health care.

- (iii) Under Centrally Sponsored Scheme of the National AYUSH Mission (NAM), there are provisions of financial assistance for establishment of new 10/30/50 bedded integrated Ayush Hospitals and establishment of AYUSH Health & Wellness Centres by upgrading AYUSH Dispensaries and existing Sub Health Centres in the States/ UTs. State/UT Governments may avail the financial assistance for establishment of new 10/30/50 bedded integrated Ayush Hospitals and establishment of AYUSH HWCs by submitting suitable proposal through State Annual Action Plans (SAAPs) as per the provision of NAM guidelines. So far 104 upto 50 bedded integrated Ayush Hospitals have been approved under NAM. State/ UT wise details are annexed at **Annexure-I**
- (iv) Union Cabinet on 20.03.2020 has approved the proposal to operationalise 12,500 Health and Wellness Centres (HWCs) through National AYUSH Mission under Ayushman Bharat in a phased manner from year 2019-20 to 2023-24. Till date, a total of 4464 facilities are approved for up-gradation as AYUSH HWCs in 33 States/UTs during

2019-20, 2020-21 and 2021-22 and Central share of Rs. 321.75 Crore has been released to these States/UTs. Out of approved 4464 AYUSH Health and Wellness Centres, 2322 units are progressively functional. State/UT wise status of approved AYUSH HWCs under the Centrally Sponsored Scheme of the National Ayush Mission is annexed at **Annexure-II**

- (v) Under Central Government Health Scheme (CGHS), total 96 Ayush units/ wellness centres are functional in the country. One Ayurvedic wellness center/ unit and one Homoeopathic wellness/ unit centre is functional in Ahmedabad and one Ayurveda wellness centre is functional at Gandhi Nagar under Central Government Health Scheme (CGHS).
- (vi) In addition, Ministry also supports the private sector to encourage them to establish Ayush super specialty hospitals under Central Sector Scheme AYURSWASTHYA YOJANA and Medical Value Travel component of Central Sector Scheme for Champion Services Sector.
- (vii) Under Centre of Excellence (COE) Component of Central Sector Scheme of AYURSWASTHYA YOJANA, financial support upto Rs. 10.0 cr. is provided to support establishment of advanced/ specialized AYUSH medical health unit in reputed AYUSH and Allopathy institutions.
- (viii) Under Medical value Travel component of Central Sector Scheme for Champion Services Sector, Ministry of Ayush provides financial assistance to the private investors in the form of interest subsidy maximum upto Rs. 8.15 cr. to encourage them to establish super specialty hospitals/ day care centers of systems recognized under National Commission for Indian System of Medicines Act, 2020 and National Commission for Homoeopathy Act, 2020 under Central Sector Scheme for establishment of Ayush super specialty hospitals/ Day care centers.
