PRODUCTION OF SUGARCANE

1081. SHRI VISHNU DAYAL RAM:

Will the Minister of AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण मंत्री be pleased to state:

- (a) the details of the total production of sugarcane in the country in the last three years and the current year;
- (b) the details of sugarcane production and exports, State-wise;
- (c) whether the Government has incentivized sugarcane farmers in the light of increased sugarcane exports; and
- (d) if so, details thereof?

(a) & (b): The details of State-wise and all-India production and export of sugarcane during last three years and the current year i.e. 2018-19 to 2021-22 are given at Annexure I & II, respectively.

(c) & (d): Major share of sugarcane produced in the country is utilized by sugar mills for production of sugar and remaining share are utilized for production of Gur, Khansari, ethanol etc. In order to encourage farmers to produce sugarcane, the Central Government fixes Fair and Remunerative Price (FRP) of sugarcane on yearly basis before commencement of every sugar season. The FRP of sugarcane for the current sugar season 2021-22 is Rs. 290/quintal at 10% recovery.
