- (e) : Steps taken by Government in the recent past to improve parcel business are as under:
  - i. Running of Time Tabled Parcel Trains and Kisan Rail services;
  - ii. Opening of all terminals for handling of parcel traffic;
  - iii. Advance booking of Parcels upto 120 days in advance;
  - iv. Leasing of Parcels Space in Parcel Vans (VPs) by Rajdhani/Duronto Train;
  - v. Utilization of Railway land for stacking/storage of Parcel consignments by parcel loading parties;
  - vi. Guidelines issued to facilitate working of City Booking Agencies;
  - vii. Provision of short term leasing of Parcel Vans (VP)/Seating cum luggage rake (SLR);
  - viii. Introduction of General Seating (GS) and New Modified Goods (NMG) coaches in Parcel specials and Kisan Rail service to increase capacity;
    - ix. Rationalization of freight rates for Parcel traffic by giving discounts in empty direction;
    - x. 8% discount of Base freight rate applicable on Indented Parcel Trains with composition 24 VP+1 SLR.
