- (a) the details of the number of artisans and weavers who have registered themselves in the Government-e-Marketplace (GeM) to enable them to sell their products directly to various Government departments and organizations, State-wise;
- (b) the number of artisans and weavers who have actively participated in trade activities on the portal out of the total registered artisans and weavers; and
- (c) the details about the number of artisans and weavers who have participated in the portal from Delhi, in absolute figures as well as comparative to the rest of India?

- (a) & (b): A total of 1,77,825 artisans and weavers are registered on Government-e-Marketplace (GeM) to sell their products directly to various Government departments and organizations. The State/UT- wise details is annexed at Annexure-I. Total sales figure as recorded on GeM portal since July 2020 till date comes to Rs 118.30 crore by the registered artisans and weavers.
- (c): 1,116 artisans & weavers have registered themselves on GeM portal. Total sales figure as recorded on GeM portal since July 2020 till date comes to Rs 19.43 crore by the registered artisans and weavers for Delhi.
