**DIGITAL PAYMENTS INFRASTRUCTURE**

**1282. SHRI VINCENT H. PALA:**

Will the Minister of ELECTRONICS AND INFORMATION TECHNOLOGY be pleased to state:

- (a) the details of the extent of digital payments infrastructure usage in North Eastern Region (NER), State-wise;
- (b) the details of ATM penetration in NER, State-wise; and
- (c) the details of the steps taken by the Government to increase connectivity and reduce server downtime/ failed transactions in the NER?

(a): Government of India is making all efforts for promotion of digital payments and enabling digital payment acceptance infrastructure across the country including North Eastern Region (NER). As a result of coordinated efforts of the Government with all stakeholders, a significant increase in number of digital payment transactions have been achieved from 2,071 crore in FY 2017-18 to 5,554 crore in FY 2020-21. A total of 6,380 crore digital payment transactions have been achieved till 02.02.2022 in FY 2021-22 (as per DigiDhan Dashboard: URL - <https://digipay.gov.in/> ).

The State-wise details of number of digital payment transactions in North Eastern Region (NER) for payment modes Unified Payments Interface (BHIM-UPI), RuPay on point of sale (PoS) devices, Immediate Payment Service (IMPS), and \*99# (Unstructured Supplementary Services Data( USSD) based digital payment mode), as per information provided by National Payments Corporation of India (NPCI), is given below:

(c): As per information provided by Department of Telecommunication, the following schemes are being implemented through Universal Service Obligation Fund(USOF) to increase connectivity in North Eastern Region to facilitate digital payments :

- BharatNet project is implemented in a phased manner to provide broadband connectivity to all Gram Panchayats (GPs) in the country, including NER.
- Scheme for provision of mobile services in uncovered villages in Assam, Manipur, Mizoram, Nagaland, Tripura, Sikkim, and Arunachal Pradesh (National Highways only) of NER and seamless coverage along National Highway.
- Scheme for provision of fourth generation (4G) mobile services in uncovered villages of Meghalaya and seamless coverage along National Highway.
- Scheme for provision of 4G mobile services in uncovered villages of Arunachal Pradesh and 2 Districts (KarbiAnglong& Dima Hasao) of Assam.

- Hiring of 10 Gbps International Bandwidth for Internet Connectivity to Agartala from Bangladesh Submarine Cable Company Limited (BSCCL), Bangladesh via Cox Bazar.
