- (c) the number of MSMEs registered in India Export Portal since the setting up of the said portal in the states of Bihar, Madhya Pradesh, Uttar Pradesh, Jharkhand, Maharashtra and Rajasthan, district-wise; and
- (d) the details of the contribution of MSMEs in total GDP and total exports of the country during the current financial year?

### **ANSWER**

# MINISTER OF MICRO, SMALL AND MEDIUM ENTERPRISES (SHRI NARAYAN RANE)

- (a): India Xports initiative has been launched by India SME Forum (ISF), a not for profit organization working for promotion of Small and Medium Enterprises. As informed by ISF, the main objective of India Xports initiative is to harness the export potential of Indian MSMEs by providing proper export orientation for exports from India, also giving information on potential Markets, HSN codes, historical trends, incentives and Promotion Schemes. No financial assistance has been provided or committed by the Ministry of MSME to India SME Forum for this initiative.
- (b): Details of registered MSMEs are given at Annexure-I.

- (c): ISF has informed that as on 31.01.2022, a total of 17258 MSMEs have registered on the India Xports portal. State-wise details of registered MSMEs on the portal are at Annexure-II.
- (d): As per information provided by National Statistical Office, the estimated Gross Value Added (GVA) of MSME sector during the last three years is as under:-
