EFFECT OF OMICRON VARIANT ON CHILDREN

1631. SHRI KRIPANATH MALLAH: T.R.V.S. RAMESH: SHRI ABHISHEK BANERJEE:

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) whether Omicron variant has affected children upto the age of 18 in the country, if so, the details thereof along with the timeline and targets for vaccination of children;
- (b) the number of children below 18 years vaccinated and unvaccinated as on date, State/UT-wise;
- (c) whether the Government has conducted a study on the impact of Omicron on children including unvaccinated ones, if so, the details thereof and the outcome thereon;
- (d) whether the impact of Omicron variant of COVID-19 would be different on the vaccinated and unvaccinated population and if so, the details thereof;
- (e) whether the Government has issued any guidelines to the States/UTs with regard to vaccination of children and if so, the details thereof; and
- (f) the list of vaccines for children that are at various stages of development along with the steps taken to promote the early development of children's vaccines?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (DR. BHARATI PRAVIN PAWAR)

(a) to (f) Omicron variant is the dominant variant in the country presently.

Vaccination of children in the age group of 15-18 years began from 3rd January 2022 across the country. As on 8th February 2022, against the estimated population of about 7.40 crore beneficiaries aged 15-18 years, around 4.99 crore (67.5%) beneficiaries have received 1st dose and 75.9 lakhs (10.2%) beneficiaries have received 2nd dose of COVID-19 vaccine.

As on 8th February 2022, States/UTs wise vaccinated children below 18 years of age are at Annexure-1.

Scientific evidence evolves globally regarding impact of omicron on vaccinated and unvaccinated population including children. The potential impact of Omicron variant on existing countermeasures including vaccine is scrutinized by technical groups worldwide. Vaccines used in National Covid-19 Vaccination Program remain effective to prevent the risk of severe disease due to COVID-19.

The Government of India has issued guideline on Covid-19 vaccination of children in the age group of 15-18 years, which is also available at Ministry of Health and Family Welfare web site: https://www.mohfw.gov.in/pdf/GuidelinesforCOVID19VaccinationofChildrenbetween15to18ye arsandPrecautionDosetoHCWsFLWs&60populationwithcomorbidities.pdf

The National Regulator i.e. Central Drugs Standard Control Organization (CDSCO) has approved following COVID-19 vaccines for restricted use in emergency situation in the age group of 12 years and above:

- 1. ZyCoV-D of M/s Cadila Healthcare Ltd.
- 2. COVAXIN of M/s Bharat Biotech international Ltd.

Further, following COVID-19 vaccines are in clinical trials in the country:

- i. M/s Serum institute of India is conducting Phase II/III clinical trial of COVOVAX in >2 to 17 years age group.
- ii. M/s Biological E Ltd. is conducting Phase II/III clinical trial of coronavirus in ≥5 to <18 years age group.
- iii. M/s Johnson & Johnson Pvt. Ltd., is conducting Phase II/III clinical trial in age group of 12-17 years.

A system is in place for fast track processing of application for clinical trial & approval for COVID-19 Vaccines by CDSCO.

The meetings of the Subject Expert Committee (SEC) evaluates the applications for conduct of clinical trials and approval of new drugs pertaining to COVID-19 drugs including vaccines are held to minimize the processing time of applications.
