BEDS RESERVED FOR ECONOMICALLY WEAKER SECTIONS

1632. SHRI SHANMUGA SUNDARAM K. SHRI VELUSAMY P.:

Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:-

- (a) Whether the Directorate of Health Services (DHS) has conducted inspection of private hospitals in Delhi to ascertain the admission of poor patients under EWS provisions;
- (b) if so, the details thereof and if not, the steps being taken to ensure the adherence of norms by the private hospitals in this regard;
- (c) whether hospitals have been ordered to reserve the stipulated quota for EWS patients for the specialist categories of treatments like liver, spinal injuries and such others and if so, the details thereof;
- (d) the steps taken by the Government to curb fraudulent conversion of free beds of EWS patients to paid category; and
- (e) whether the Government is having any proposal to impose monetary penalty for not adhering to the guidelines prescribed in this regard and if so, the details thereof?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (DR. BHARATI PRAVIN PAWAR)

(a) to (e):. Healthis a state subject, it is for the respective State / Union Territory government to ensure that private hospitals provide free treatment to the poor patients as per their norms including monitoring thereof and curb any kind of fraudulent practice by them and take punitive measures.

As informed by the Government of National Capital Territory of Delhi (GNCTD), inspection of private hospitals in Delhi has been carried out as per details, which are annexed.

As per guidelines issued by GNCTD, all identified private hospitals, which were allotted land at concessional rates by land owning agencies, were directed to provide 10% In Patient Department(IPD) and 25% of total Out Patient Department (OPD), completely free of any charges to eligible patients of Economically Weaker Section (EWS) category. The identified private hospital have been directed to reserve 10% of their total ward bed capacity as well as

10% of their total ICU bed capacity. However, beds are not reserved speciality-wise in identified private hospitals.

Various steps have been taken by the GNCTD to curb fraudulent conversion of free beds of EWS patients to paid category such as: -

- a) All identified private hospitals have been directed to earmark the free beds and affix a board on the wall towards the head-end of each free bed mentioning "FREE BED"
- b) Real-time availability of beds is available on the public portal
- c) Senior Nursing Officers have been posted as Liaison Officer in identified private hospitals to facilitate the patients and monitor free beds
- d) Regular inspections by the Monitoring Committee constituted by GNCTD

GNCTD does not have any proposal to impose monetary penalty for non-adherence to the guidelines prescribed in this regard. However, the implementation of the guidelines is monitored on a day to day basis by the Government.
