PM AYUSHMAN BHARAT HEALTH INFRASTRUCTURE MISSION

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) whether the Government has recently implemented PM Ayushman Bharat Health Infrastructure Mission (PMABHIM) for strengthening healthcare infrastructure in the country;
- (b) if so, the details thereof including the proposed new healthcare infrastructure in Uttar Pradesh, district-wise including Bulandshahar;
- (c) whether the PMABHIM proposes to build an IT enabled disease surveillance system by developing a network of surveillance laboratories at block, district, regional and national level;
- (d) if so, the details thereof; and
- (e) the other steps being taken by the Government in this regard?

(a) to (e):

Pradhan Mantri Ayushman Bharat Health Infrastructure Mission (PM-ABHIM) launched with an outlay of Rs.64,180 Crores to fill critical gaps in public health infrastructure over the period of five years from FY 2021-22 to 25-26. This is the largest pan-India scheme for strengthening healthcare infrastructure across the country. The measures under the scheme focus on developing capacities of health systems and institutions across the continuum of care at all levels viz. primary, secondary and tertiary and on preparing health systems in responding effectively to the current and future pandemics/disasters.

The components of the PM-ABHIM scheme are:

Centrally Sponsored Components:

1. Support for 17,788 rural Health and Wellness Centres in 10 High Focus States.
2. Establishing 11,024 urban Health and Wellness Centres in all the States.
3. 3382 Block Public Health Units in 11 High Focus states.
4. Setting up of Integrated Public Health Labs in all districts.
5. Establishing Critical Care Hospital Blocks in all districts with population more than 5 lakhs.

Central Sector Components

1. 12 Central Institutions as training and mentoring sites with 150 bedded Critical Care Hospital Blocks;
2. Strengthening of the National Centre for Disease Control (NCDC), 5 New Regional NCDCs and 20 metropolitan health surveillance units;
3. Expansion of the Integrated Health Information Portal to all States/UTs to connect all public health labs;
4. Operationalisation of 17 new Public Health Units and strengthening of 33 existing Public Health Units at Points of Entry, that is at 32 Airports, 11 Seaports and 7 land crossings;
5. Setting up of 15 Health Emergency Operation Centres and 2 container based mobile hospitals; and Setting up of a national institution for One Health, 4 New National Institutes for Virology, a Regional Research Platform for WHO South East Asia Region and 9 Bio-Safety Level III laboratories.

The implementation of the scheme along with detailed planning and district-wise allocation under various components of the PM-ABHIM lies with the State government. Hence, the ministry does not maintain district-wise information for all the components.

Further, the financial provision of Rs 8961.00 crores have been made to the State of Uttar Pradesh for construction of 4,862 'Building-less' SHCs towards Infrastructure support for AB-HWCs, establishment & operationalization of 1,329 Urban Health and Wellness Centres, 825 Block Public Health Units, 75 District Integrated Public Health Labs and 74 Critical Care Blocks over the period of five years from FY 2021-22 to FY 2025-26. Year wise physical deliverable has been communicated to the State for implementation of the scheme in a timely manner. Details of details of the budgetary outlay for the State of Uttar Pradesh for CSS component under PM-ABHIM is at Annexure- A.

PM-ABHIM envisages strengthening health care infrastructure across the country and targets to build an IT enabled disease surveillance system by developing a network of surveillance laboratories at Block, District, regional and national levels, in metropolitan areas and strengthening health units at the Points of Entry, and combating Public Health Emergencies and disease outbreaks.
