**FUNDS ALLOCATION UNDER NATIONAL AYUSH MISSION**

**1785. ADV. DEAN KURIAKOSE:**

Will the Minister of **AYUSH** be pleased to state:

(a) the amount of funds allocated to each state during the last five years under National AYUSH Mission (NAM), State/UT-wise;

(b) whether Sports Ayurvedic Centre project is permissible under NAM;

(c) if so, whether such a centre is being considered to be set up in Thodupuzha, Kerala;

(d) whether the increase in salary of the employees is being considered under NAM and if so, the details thereof; and

(e) whether further benefits under ESI and PF is proposed to be included into the basic salary structure of the employees under NAM and if so, the details thereof?

**ANSWER

(a) The State/UT-wise amount of funds allocated to each State during the last five years from 2016-17 to 2020-21 under the National AYUSH Mission (NAM), is furnished at **Annexure**.

(b) Under the NAM, there is no specific provision for Sports Ayurvedic Centre project. However, under the Flexipool component of the NAM, State/UT Governments may avail the eligible financial assistance by submitting the suitable proposal through State Annual Action Plans (SAAPs) as per the NAM guidelines.

(c) Public Health being a State subject, setting up of Sports Ayurvedic Centre in Thodupuzha, Kerala comes under the purview of the respective State Government.

(d) & (e) Public Health being a State subject, the implementation of the NAM Scheme including appointment of the Manpower and providing further benefits under ESI and PF comes under the purview of the respective State/UT Government. However, the role of Ayush Ministry is to consider the proposals received under various activities including

remuneration of the deployed manpower from State/UT Governments as submitted through SAAPs as per the NAM guidelines.
