- (c) the number of requests/proposals currently pending with the Railways for the states of Jammu and Kashmir and Bihar; and**
- (d) the reasons for the pendency of the said proposals?**

STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (d) OF UNSTARRED QUESTION NO. 182 BY SHRI JUGAL KISHORE SHARMA AND SHRI DILESHWAR KAMAIT TO BE ANSWERED IN LOK SABHA ON 02.02.2022 REGARDING RAILWAY WORKS FOR JAMMU AND KASHMIR/BIHAR.

(a) to (d) : Proposals/requests/suggestions/demands related to Railway works, both formal as well as informal, are received from State Governments, Ministries of Central Government, elected representatives, organizations/Rail users etc. by Railways at various levels i.e. Railway Board, Zonal Railways and Divisional Headquarters, etc. As receipt of such proposals/requests/suggestions/demands is a continuous and dynamic process, centralized compendium of such requests is not maintained.

During last three years i.e. from 2018-19 till date 15 no. of surveys for new line, doubling projects have been sanctioned in Bihar and 01 no. of New line survey has been sanctioned in Jammu & Kashmir. As on 01.04.2021, 03 nos. of projects (01 New line and 02 Doubling) of total length 481 Km costing Rs.28,856 Crore falling fully/partly in Jammu & Kashmir and 57 nos. of projects (35 New line, 05 Gauge conversion and 17 Doubling) of total length 5267 Km costing Rs.76137 Crore falling fully/partly in Bihar are in different stages of planning/sanction/execution.
