Directions for Extended Producers Responsibility

1866. SHRI T.N. PRATHAPAN: SHRI UDAY PRATAP SINGH:

Will the Minister of ENVIRONMENT, FOREST AND CLIMATE CHANGE be pleased to state:

- (a) whether the Government has issued directions to the States regarding the Registration of plastic brand owners/producers for fulfilment of extended producers responsibility (EPR) as per Plastic Waste Management Rules;
- (b) if so, the details in this regard along with the details of non-compliant producers/brand owners, State/UT-wise;
- (c) whether the Government has the year-wise data of plastic waste in the country since 2010 and if so, the details thereof;
- (d) the details of plans that the Government has taken so far to reduce the threat from plastic waste crisis;
- (e) the Government's plan to restrict/minimizing the use of plastic to promote other alternatives; and
- (f) the details of the measures taken towards creating awareness and public participation for clean environment?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT, FOREST AND CLIMATE CHANGE (SHRI ASHWINI KUMAR CHOUBEY)

(a) & (b): The Central Pollution Control Board had issued directions under Section 5 of the Environment (Protection) Act, 1986, on 6th October, 2020, to State Pollution Control Boards / Pollution Control Committees(SPCBs/PCCs) regarding registration of plastic brand owners/producers and fulfillment of extended producer responsibility as per provisions of Plastic Waste Management Rules, 2016. The SPCBs/PCCs were directed to identify the brand owners/producers operating without registration under Plastic Waste Management Rules, 2016 in area under their jurisdiction. A list of 78 brand owners / producers who had applied for registration to CPCB but had not responded to queries raised by CPCB for long time were deemed to be non-compliant under the said directions. The state-wise list is at Annexure I.

(d): The Plastic Waste Management Rules (PWMR), 2016, provides the statutory framework for plastic waste management in an environmentally sound manner throughout the country. Considering the adverse effect of littered single use plastic items on terrestrial, aquatic and marine ecosystems, the Ministry has notified the Plastic Waste Management Amendment Rules, 2021, on 12th August 2021, prohibiting identified single use plastic items, which have low utility and high littering potential, from 1st July 2022. The Ministry of Environment, Forest and Climate Change has also notified the Guidelines on the Extended Producer Responsibility for plastic packaging vide Plastic Waste Management Amendment Rules, 2022, on 16th February, 2022.

Further, the States/UTs have been requested to constitute a Special Task Force under Chairpersonship of Chief Secretary/Administrator for elimination of single use plastics and effective implementation of PWMR, 2016. Thirty two States/UTs have constituted the Special Task Force till date. A National Level Taskforce has also been constituted by the Ministry in this regard. The State /UT Governments and concerned Central Ministries/Departments have also been requested to develop a comprehensive action plan and implement it in a time bound manner. The Government of India provides additional central assistance to the States/UTs under the Swachh Bharat Mission for solid waste management including plastic waste management. Swachh Bharat Mission Urban 2.0 has specific focus on elimination of single use plastics.

(e) & (f): The Ministry of Micro, Small and Medium Enterprises has taken steps to encourage transition from single use plastic items to alternate materials. NITI Aayog has already constituted a Committee to find out/develop an alternative product to plastic.

The Ministry of Environment, Forest and Climate Change, organized a series of awareness programme to avoid the use of single-use plastics across the country, as part of Iconic Week celebrations from 4th to 10th October, 2021, under Azadi Ka Amrit Mahotsav. A separate Awareness Campaign on Single Use Plastic was also organized in 2021. In order to spread awareness amongst school students in the countrya pan India essay writing competition was also organized. The Ministry organized India Plastic Challenge – Hackathon 2021, to encourage innovation in development of alternatives to identified single use plastic items and digital solutions to plastic waste management.
