- (a) the mechanism that has been adopted for monitoring the various missions under the National Action Plan for Climate Change (NAPCC);
- (b) the status of the various missions under the NAPCC; and
- (c) the details of the funding for each of the missions over the last three years and current year?

(a) to (c) Missions under the National Action Plan on Climate Change (NAPCC) have been revised to align with India's Nationally Determined Contributions (NDCs) under the Paris Agreement. Implementation of National Missions is funded by the respective Ministries/Departments anchoring the Missions. Details of funding for National missions under NAPCC over the last three years and current year is given in Annexure – I. Government of India has constituted high level committees, including an inter-ministerial Apex Committee as well as an Executive Committee on Climate Change for monitoring progress in Missions under NAPCC.
