**FUNDS TO STATES TO ORGANISE FAIRS AND FESTIVALS**

**1899. SHRI JUAL ORAM:**

**Will the Minister of CULTURE be pleased to state:**

- (a) whether the Union Government is providing funds to the States to organize fairs and festivals and if so, the details thereof;  
(b) whether the assistance is extended to the States to promote tribal culture also; and  
(c) if so, the details thereof along with the funds provided to different States during the last three years?

(a) No, Sir. State/ UT-wise funds are not released by the Ministry of Culture, Government of India to organize fairs and festivals.

The Ministry of Culture organizes National Level Festivals like Rashtriya Sanskriti Mahotsavs (RSMs) through its Zonal Cultural Centres (ZCCs) where a large number of artists from all over India are engaged to showcase their talents. Besides RSMs, ZCCs also organize Regional Festivals alongwith other cultural activities/ programmes for promotion of culture every year as per their programme calendar. The grant-in-aid released to these ZCCs during the last three years for organizing their activities including Regional Festivals and RSMs is as under:

(b) & (c) Since 2007, Ministry of Tribal Affairs, Government of India is running a special scheme called Conservation cum Development Plan (CCD), meant for the 75 identified Particularly Vulnerable Tribal Groups (PVTG) in the Country. Under this centrally sponsored scheme, the grants are given to States and Union Territories inhabited by such tribal groups to ensure that along with development interventions, the culture of such communities is also preserved, protected and promoted. The Ministry allocates annual budgetary provision to the States/UTs where the PVTGs inhabit. Details of funds released to the State Governments during the last three years under the scheme of 'Development of PVTGs' are as under:

Further 27 Tribal Research Institutes (TRI) have been set up across the country with an objective to act as a think tank and become repository of information on tribal communities. Under the scheme "Support to TRIs", the Ministry of Tribal Affairs provides funds to TRIs for undertaking studies and documentation on life and culture of tribal communities including tribes of North East. TRIs have conducted documentation (Audio-Video, photos and documentation in written and published form) of indigenous knowledge systems practices, cultures and customs of the tribal communities. Details of funds released to the State Governments during the last three years under the Scheme of 'Support to Tribal Research Institutes' are as under:
