# MINISTER OF STATE FOR TRIBAL AFFAIRS (SMT. RENUKA SINGH SARUTA)

(a & b) : Ministry of Tribal Affairs provides financial assistance to State Governments under the scheme "Support to Tribal Research Institutes" since 2017-18, wherein funds are given to TRIs for various activities related to research, programs for preservation of tribal cultural heritage, and training and capacity building programs on various issues including implementation of Forest Rights Act. Earlier this scheme was known as 'Research and Training' being implemented since first five year plan.
