STOPPAGE AT KISHANGARH STATION

†214. SHRI BHAGIRATH CHOUDHARY:

Will the Minister of RAILWAYS be pleased to state:

(a) whether there has been a long standing demand for the stoppage of train no. 15715-15716 (Garib Nawaz Express), train no. 19333-19334 (Bikaner-Indore) and train no. 12915-12916 (Ashram Express) at Kishangarh (Ajmer) Railway Station and if so, the details thereof;

(b) whether there has been a stoppage of train no. 15715-15716 (Garib Nawaz Express) at Khairthal, Dausa, Phulera and train no. 19333-19334 (Bikaner-Indore) at Kishangarh Renwal, Nawalgarh, Sudsar and train no. 12915-12916 (Ashram Express) at small or low income stations like Rajgarh, Bandikui, Dausa, Beawar and Phulera, if so, the reasons for not permitting stoppages at these Railway Stations by Railway Board despite these stations being remunerative and if so, the details thereof; and

(c) the Comparative details of the total daily passengers as well as the income of Kishangarh (Ajmer) Railway Station to the stations where these trains have stoppage during January 2019 to 31 December, 2019?

STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (c) OF UNSTARRED QUESTION NO. 214 BY SHRI BHAGIRATH CHOUDHARY TO BE ANSWERED IN LOK SABHA ON 02.02.2022 REGARDING STOPPAGE AT KISHANGARH STATION

(a) and (b) Demands, including that from the Hon'ble Member of Parliament, have been received. Demands for provision of stoppage of trains at the stations, where they presently do not have scheduled stoppage, have been examined but found operationally not feasible, for the present. However, provision of stoppages is an ongoing process on Indian Railways, subject to operational feasibility and commercial justification etc.

(c) Comparative analysis of total number of passengers and daily average of number of passengers (both outwards and inwards combined), for stations Nawalgarh, Renwal, Sudsar, Dausa, Khairthal, Rajgarh, Bandikui, Phulera, Beawar and Kishangarh during the period 01.01.2019 to 31.12.2019, is as below:
