2205. SHRI GANESH SINGH:

Will the Minister of SOCIAL JUSTICE AND EMPOWERMENT be pleased to state :

(a) whether the Government has received proposals from the States regarding Accessible India Campaign;

(b) if so, the number of proposals sanctioned/ pending, State-wise including Madhya Pradesh; and

(c) the time by which pending proposals are likely to be sanctioned?

ANSWER

MINISTER OF STATE FOR SOCIAL JUSTICE AND EMPOWERMENT (SUSHRI PRATIMA BHOUMIK)

(a): Yes, Sir. The Government has received proposals from the States/UTs under the subscheme 'Accessible India Campaign' under the Scheme "Scheme for Implementation of Rights of Persons with Disabilities Act, 2016 (SIPDA)".

(b) & (c): Under the Accessible India Campaign, 1671 buildings were audited for providing accessibility features in the most important government buildings in 48 cities. Out of these 1671 buildings, proposals for 1484 buildings were received from States/UTs and out of these 1484 buildings, 1191 buildings were given funds as the proposals were found to be compliant with provisions of the Scheme. Status of proposals sanctioned/ pending, state-wise, including Madhya Pradesh, is at **Annexure I.**

The Proposals for retrofitting of balance buildings could not be processed mainly because of receipt of incomplete proposals from States/UTs, unavailability of utilization certificates for previously released grants and the proposals being non-compliant to the standard of accessibility features provided in Harmonized Guidelines. At present, the Department of Empowerment of Persons with Disabilities has received proposals for retrofitting of 146 buildings for 6 states which would be processed as per the Scheme guidelines.
