CONSTRUCTION OF NEW HOUSES UNDER PMAY-G

2235. SHRI. RAMESH CHANDRA MAJHI:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) whether the Government has approved construction of new houses under Pradhan Mantri Awas Yojana-Gramin (PMAY-G) in the recent past and if so, the details thereof:
- (b) the details of the States selected for construction of such houses in the country including State of Odisha;
- (c) the details of the criteria fixed for selection of States for the said purpose; and
- (d) the details of the PMAY-G houses under construction in various States;
- (e) the total funds sanctioned, released and utilized so far for construction of such houses and the time by when these houses are likely to be completed, State/UTwise including Odisha?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SADHVI NIRANJAN JYOTI)

(a) to (c) In order to achieve the target of "Housing for All" in rural areas, the Ministry of Rural Development is implementing Pradhan Mantri Awaas Yojana- Gramin (PMAY-G) with effect from 1st April, 2016 to provide assistance to eligible rural households with overall target to construct 2.95 crore pucca houses with basic amenities by March, 2024. The identification of beneficiaries under PMAY-G is based on the housing deprivation parameters and exclusion criteria prescribed under Socio Economic Caste Census (SECC)-2011 and due verification by the respective Gram Sabhas and completion of an Appellate Process.

Out of the total target of 2.95 crore houses, a target of 2.62 crore (88.81% of total) houses has been allocated to the States/ UTs, 2.28 crore (76.9% of total) beneficiaries have been sanctioned houses by the States/UTs, 1.74 crore houses have been completed as on 09.03.2022.

The targets under PMAY-G are allocated annually on the basis of availability of eligible beneficiaries, achievements of targets allocated during the preceding years and proposal submitted by the States/UTs.

- (d) The State-wise details of targets allocated, houses sanctioned, completed and under construction as on 09.03.2022 under PMAY-G are given in **Annexure-I**.
- (e) The State-wise details of central funds released and expenditure incurred (including State Share) from 2016-17 to 2021-22 (as on 09.03.2022) is given in **Annexure-II**. The target date for completion of PMAY-G is March, 2024.
