(a) & (c) The completion of Electrification project depends upon various factors like clearances from the concerned Departments/State Governments/Central Ministries, completion of Transmission Line works by State Power Utilities and resolution of law & order issues during execution, which are beyond the control of Ministry of Railways. Therefore, it is not feasible to fix time lines for completion of the project.

(b) Funds for Railway Electrification are sanctioned pan India basis and not State wise every year in the Budget; Budget Allocation and Expenditure for Plan Head 'Railway Electrification' during 2020-21 & 2021-22 are as under:
