**Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:**

- (a) the details of funds allocated, released and utilized by Maharashtra, Karnataka and Jharkhand under Atal Mission for Rejuvenation and Urban Transformation (AMRUT) during the last three years, year and State-wise;**
- (b) the number of projects implemented under the Scheme in the States particularly in Madha Lok Sabha Constituency and Latur district in Maharashtra and Chatra, Latehar and Palamu districts in Jharkhand during the said period;**
- (c) the number of projects/proposals pending under the scheme in the said States particularly in Madha and the above said districts during the said period; and**
- (d) the steps taken by the Government for implementation of all the pending projects/proposals under the scheme in Maharashtra, particularly in Madha and the above said districts?**

**(a): Under Atal Mission for Rejuvenation and Urban Transformation (AMRUT), approved plan size of State of Maharashtra is ₹7,759.32 crore for the entire Mission period which includes committed Central Assistance of ₹3,534.80 crore. Similarly, approved plan size of State of Karnataka is ₹4,952.87 which includes committed Central Assistance of ₹2,318.79 crore and approved plan size of State of Jharkhand is ₹1,245.74 which includes committed Central Assistance of ₹566.17 crore.**

**Details of funds released for AMRUT projects and utilized by the State of Maharashtra, Karnataka and Jharkhand during the last three years are given as under:**

**(b): Government of Maharashtra has taken up 196 projects under AMRUT worth ₹7,826 crore, of which 139 projects worth ₹1,252 crore have been completed and remaining projects are under implementation.**

**Government of Karnataka has taken up 407 projects under AMRUT worth ₹5,119 crore, of which 347 projects worth ₹2,665 crore have been completed and remaining projects are under implementation.**

**Government of Jharkhand has taken up 59 projects under AMRUT worth ₹1,615 crore, of which 41 projects worth ₹214 crore have been completed and remaining projects are under implementation.**

**AMRUT cities of Barshi, Solapur and Satara fall in Madha Lok Sabha constituency and Latur and Udgir fall in Latur District. Status of AMRUT projects in these cities are given as under:**
