CONTRIBUTION OF MSMEs IN GDP, EMPLOYMENT AND EXPORTS

2742. SHRIMATI PRATIMA MONDAL:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) the contribution of Micro, Small and Medium Enterprises (MSMEs) in the country's GDP, employment and value exports during each of the last three years and the current year;
- (b) whether exports of MSMEs have been affected due to Covid-19 pandemic;
- (c) if so, whether the Government has initiated a plan of action to extend requisite support to MSMEs to make their export more competitive and if so, the details thereof; and
- (d) the extent to which the Government has achieved success in this regard so far?

ANSWER

(a): As per the information received from Ministry of Statistics and Programme Implementation, the share of MSME Gross Value Added in All India GDP at current prices are as follows:

- (b): COVID-19 epidemic has temporarily affected various sectors including Micro, Small and Medium Enterprises in the country including their export.
- (c): The Ministry of MSME is implementing the International Cooperation (IC) Scheme. The scheme aims at capacity building of MSMEs for entering export market by facilitating their participation in international exhibitions/fairs/conferences/seminar/buyer-seller meets abroad as well as providing them with actionable market-intelligence and reimbursement of various costs involved in export of goods and services.
- (d) The impact of COVID 19 pandemic has temporarily affected the Indian export sector as a whole and also exports from MSME Sector. However, the share of export from MSME sector in total export remained almost same in 2020-21 (49.35%) as compared to 2019-20 (49.77%)
