(b) The Ministry of Skill Development and Entrepreneurship is delivering skills through following skill development schemes across the country:

1	Pradhan Mantri Kaushal VikasYojana (PMKVY)	With an aim to empower country's youth and continue the journey of Skill India Mission in building India as the skill capital of the world, the Ministry of Skill Development and Entrepreneurship (MSDE) launched the third phase of its flagship scheme— Pradhan Mantri Kaushal Vikas Yojana (PMKVY 3.0) in January 2021.
2	Jan Shikshan Sansthan (JSS) Scheme	Scheme of Jan ShikshanSansthan (NGOs) for Skill Development to impart vocational skills in non-formal mode to non-literate, neo-literates, persons with rudimentary level of education upto 8 th and school drop-outs upto 12 th standard in the age group of 15-45 years. The priority groups are women, SC, ST, minorities and other backward sections of the society.
3	National Apprenticeship Promotion Scheme (NAPS)	This Scheme is for promoting apprenticeship training and increasing the engagement of apprentices by providing financial support to industrial establishments undertaking apprenticeship program under The Apprentices Act, 1961.

Further, under the Skill India Mission, the Government is implementing various Skill Development Schemes/Programmes across Central Ministries/Departments, for providing a range of Skill Development training programmes on pan India basis. Amongst other major schemes for skilling run by other Ministries, Ministry of Rural Development is implementing Deen Dayal Upadhyaya Grameen Kaushalya Yojana (DDU-GKY) and Rural Self Employment Training Institutes (RSETIs) schemes, while the Ministry of Housing and Urban Affairs is implementing the Deen Dayal Antyodaya Yojana- National Urban Livelihoods Mission (DAY-NULM).
