QUESTION Funds Allocation by Ministries to NER

2892. SHRI INDRA HANG SUBBA:

Will the Minister of DEVELOPMENT OF NORTH EASTERN REGION be pleased to state:

(a) the details of Ministry-wise allocation and expenditure incurred of 10 per cent of the budget committed for North East Region (NER) during the last five years; and
(b) the percentage thereof utilised in education and road development respectively in NER?

ANSWER

The Minister of the Ministry of Development of North Eastern Region [Shri G. Kishan Reddy]

(a) In all, 54 non-exempted Central Ministries/Departments, are presently mandated to spend atleast 10% of their Gross Budgetary Support (GBS) for Central Sector and Centrally Sponsored Schemes in North East Region (NER). The details of Budget Estimates, Revised Estimates and Actual Expenditure under 10% GBS during the last five years from 2016-17 to 2021-22 is given in Table 1 below.
