- (a) the aims and objectives of the PM SVANidhi Scheme;**
- (b) the budgetary outlay and phases of implementation of the PM SVANidhi Scheme;**
- (c) the number of beneficiaries in the state of Rajasthan, district-wise and the details of the progress thereof;**
- (d) whether the Government has taken any steps for welfare and economical upliftment of Street Vendors across the country;**
- (e) if so, the details thereof; and**
- (f) the total number of Street Vendors benefitted under PM SVANidhi Scheme, State/UT-wise?**

**ANSWER
THE MINISTER OF HOUSING AND URBAN AFFAIRS**

(a): Ministry of Housing and Urban Affairs (MoHUA) has launched the Prime Minister Street Vendor's AtmaNirbharNidhi (PM SVANidhi) Scheme on June 01, 2020 with the aim to facilitate collateral free

working capital loan to street vendors to restart their businesses, which were adversely impacted during the Covid-19 pandemic. The Scheme has the following objectives:

- i. Facilitate collateral free working capital loan up to ₹10,000, of 1 year tenure, with enhanced loan of ₹20,000 and ₹50,000 in the second and third tranches respectively, on repayment of earlier loans.**
- ii. Incentivize regular repayment, through interest subsidy @ 7% per annum; and**
- iii. Reward digital transactions, by way of cash back up to ₹1,200 per year.**

(b): An amount of ₹113.6 Cr was allocated during financial year 2020-21, while ₹200 Cr was allocated for the financial year 2021-22. In the first phase, Scheme targets to provide 30 lakh loans to street vendors with a total outlay of ₹600 Cr.

(c): The total number of PM SVANidhi beneficiaries in the State of Rajasthan is 66,737. The district-wise, number of beneficiaries in Rajasthan are at Annexure-I.

(d) and (e): Yes, Sir. Ministry of Housing and Urban Affairs has launched a program - 'SVANidhi se Samridhi' under PM SVANidhi Scheme, in 125 select Urban Local Bodies (ULBs), on January 4, 2021. This programme facilitates linkages to 8 select Central Government welfare schemes designed to provide a safety net and social security for the eligible beneficiaries and their families. These 8 Schemes are (i) Pradhan Mantri Jeevan Jyoti Bima Yojana (ii) PM Suraksha Bima Yojana (iii) Pradhan Mantri Jan Dhan Yojana (iv) Registration under Building and other Constructions Workers (Regulation of Employment and Conditions of Service) Act (BOCW) (v) Pradhan Mantri Shram Yogi Maandhan Yojana (vi) National Food Security Act (NFSA) portability benefit – One Nation One Ration Card (ONORC)(vii) Pradhan Mantri Janani Suraksha Yojana and (viii) Pradhan Mantri Matru Vandana Yojana (PMMVY).

As on January 27, 2022, socio economic profiling is completed for 7.7 lakh PM SVANidhi beneficiaries along with 15 Lakh family members and a total of 16.40 lakh scheme benefits have been extended to them.

In the State of Rajasthan, 9 cities, namely—Ajmer, Bharatpur, Bhilwara, Bikaner, Jodhpur-North, Jodhpur-South, Kota-North, Kota-South and Udaipur are selected under ‘SVANidhi se Samriddhi’ program. A total of 8,288 scheme benefits of the above-mentioned welfare schemes have been extended to eligible Street vendors and their families.

(f): As on January 27, 2022, total number of Street Vendors benefitted under PM SVANidhi Scheme is 28,14,994.State and UT wise details are at Annexure-II.
