Will the Minister of FINANCE be pleased to state:

- a) the details and the amount of loans taken by various States/ UTs of the country including Chhattisgarh during the financial years 2018-19, 2019-20, 2020-21, and 2021-22 along with the names of the institutions from which these loans were taken, year-wise;
- b) whether the reasons and utility of such loans are reviewed by the Government and if so, the details thereof; and
- c) if not, whether the Government is likely to review the said loans and if so, the time by which it is likely to be done?

(a) As gleaned from Reserve Bank of India report titled 'State finances: A study of budgets of 2020-21' and 'State finances: A study of budgets of 2021-22', the State-wise details of amount of loans taken by various States/UTs including Chhattisgarh during the financial year 2018-19, 2019-20, 2020-21(RE) and 2021-22 (BE) are at **Annexure I to Annexure IV**.

(b) &(c) All States have enacted their Fiscal Responsibility and Budget Management (FRBM) Act. Compliance to the State FRBM Act is monitored by the respective State legislatures.
