**Funds under Andhra Pradesh Reorganisation Act, 2014**

Will the Minister of FINANCE be pleased to state:

- (a) the details of funds for various sectors committed under the Andhra Pradesh Reorganisation Act, 2014 to Telangana State, sector-wise;
- (b) the details of funds allocated from 2014 to 2022 to Telangana State under the Andhra Pradesh Reorganisation Act, 2014, sector-wise;
- (c) whether any proposed fund is still pending for Telangana even after seven years of the Andhra Pradesh Reorganisation Act, 2014; and
- (d) if so, the reasons for the delay?

(a) to (d): Following Section 94(2) of the Andhra Pradesh Reorganisation Act (APRA), 2014, the Government of India has released an amount of Rs. 2250.00 crore for development works in 9 backward districts of the State of Telangana. This includes an amount of Rs. 450.00 crore released on 31.03.2021. The year-wise details of the Special Assistance provided under Section 94(2) of the APRA, 2014 to the State of Telangana are as under:
