Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the details of the total allocated budget under Pradhan Mantri Awaas Yojana Gramin (PMAY-G) for the poor people living in rural areas during each of the last three years, year/State-wise;
- (b) the details of the target fixed for the housing of rural areas of Maharashtra in the current financial year; and
- (c) whether any survey was conducted in this regard and if so, the details of the target fixed, year-wise?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SADHVI NIRANJAN JYOTI)

- (a) The Year-wise and State-wise details of the total funds released under Pradhan Mantri Awaas Yojana-Gramin (PMAY-G) for the poor people living in rural areas during each of the last three years i.e. financial year (FY) 2018-19 to 2020-21 is given at **Annexure**.
- (b) Under PMAY-G, a target of construction of 3,91,921 houses has been allocated to the State of Maharashtra during current FY i.e. 2021-22.
- (c) The beneficiaries under the scheme are identified from Socio Economic Caste Census (SECC) 2011 and Awaas+ survey. Against the overall target for construction of 2.95 crore houses under PMAY-G, a target of 2.62 crore (approx.) houses has already been allocated to the States/UTs from financial year 2016-17 till 2021-22. The Year-wise breakup of the targets allocated to the States/UTs is given in the table below:
