**3028. SHRI RAJIV RANJAN SINGH ALIAS LALAN SINGH:
SHRIMATI RAMA DEVI:**

Will the Minister of *FOOD PROCESSING INDUSTRIES* be pleased to state:

- (a) the number of food processing parks approved and being established in all over the country during the last five years, State-wise;
- (b) the status of all those food processing parks;
- (c) the number of proposals received by the Government from the State of Bihar for setting up of food parks and the status of the said proposals along with the number of proposals approved by the Government; and
- (d) the number of food parks in Bihar at present and the details of the employment and revenue generated therefrom?

ANSWER

(a) & (b): Ministry has approved 10 Mega Food Parks (MFPs) and 68 Agro Processing Clusters (APCs) (similar to mini food parks) during the last five years in the country. Details of these MFPs and APCs along with their status is at **Annexure-I** & **Annexure-II** respectively.

(c) & (d): Ministry has received 4 and 5 proposals for setting up of MFPs and APCs respectively during the last five years from the State of Bihar. Out of these, one MFP project and one APC project have been approved by the Ministry. Presently one Mega Food park and one Agro Processing cluster projects are under implementation in the state of Bihar.
