REQUISITION UNDER NPOP

3058: SHRI PARVESH SAHIB SINGH VERMA:

Will the Minister of AGRICULTURE AND FARMERWELFARE कृषि एवं किसान कल्याण मंत्री be pleased to state:

- (a) the details about the total area required for organic certification process registered under the National Programme for Organic Production(NPOP), State-wise;
- (b) whether the Government has any data on the installed production capacity and the under-utilisation capacity figures of the bio-fertilizers in the country and if so, the details thereof;
- (c) whether the farmers in Delhi and adjoining areas have been encouraged to use bio-fertilizers instead of chemical fertilizers; and
- (d) if so, the details of land under organic farming in Delhi/NCR?

ANSWER

(a) to (d): The State-wise detail on the total area under organic certification process under the National Programme for Organic Production (NPOP) is given at **Annexure I**.

Government is promoting organic farming through dedicated organic farming schemes of Paramparagat Krishi Vikas Yojana (PKVY) and Mission Organic Value Chain Development in North East Region (MOVCDNER) since 2015-16 in States including Delhi/ NCR. Under these schemes, farmers are primarily encouraged to adopt organic cultivation using various organic inputs including bio- fertilizers and provided end to end from production to marketing of organic produce. Hands-on training to farmers about on-farm production of organic fertilisers and its use are integral part of these schemes. Farmers are provided subsidy of Rs 31000/ ha / 3 years under PKVY and Rs 32500/ ha/ 3 years under MOVCDNER for various organic inputs including bio- fertilizers. The State-wise consumption of bio-fertilizers during last three years is given at **Annexure II** and the land area under organic farming in Delhi as registered on PGS- India certification portal is 8259.74 ha.
