Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the total coverage achieved under PMGSY until 2021;
- (b) the special measures taken by the Government to provide road connectivity in Left Wing Extremist areas and the North East of India;
- (c) whether the Pradhan Mantri Gram Sadak Yojana (PMGSY) has projects in the districts of Palamu and Garhwa;
- (d) if so, the details thereof;
- (e) the details of the PMGSY projects that are proposed, ongoing and completed in Jharkhand;
- (f) whether it is true that the Government is planning to discontinue the PMGSY;
- (g) if so, the details thereof?

(a) Since inception till 31^{st} December, 2021, the details of works sanctioned, completed and balance under various interventions/verticals of PMGSY are given as under:-

(b) North East Areas and Left Wing Extremism Areas of India have got specific focus in PMGSY by giving special dispensation to these areas. While eligibility criteria for other habitations for getting connectivity under the scheme is a population of 500 persons (as per 2001 census) in plain areas, for Tribal (Schedule V) areas and Selected Tribal and Backward Districts (as identified by the Ministry of Home Affairs and Planning Commission) and for special category states, mostly **North-Eastern** and Himalayan States (i.e. Arunachal Pradesh, Assam, Manipur, Meghalaya, Mizoram, Nagaland, Sikkim, Tripura, Himachal Pradesh, Jammu & Kashmir and Uttarakhand), unconnected habitations

with a population of 250 persons and above (as per Census 2001) are eligible for providing all-weather road connectivity under the scheme. In the critical **Left Wing Extremism** (**LWE**) affected blocks (as identified by MHA), additional relaxation has been given to connect eligible habitations with population 100 persons and above (as per Census 2001).

Further, with an aim to improve the road connectivity in 44 worst affected LWE districts and some adjoining districts in 9 States, viz. Andhra Pradesh, Bihar, Chhattisgarh, Jharkhand, Madhya Pradesh, Maharashtra, Odisha, Telangana and Uttar Pradesh, Road Connectivity Project for Left Wing Extremism Areas (RCPLWEA) was launched in the year 2016. The scheme has twin objectives of enabling smooth and seamless anti-LWE operations by the security forces and also ensuring socio-economic development of the area. So far, 10,231 km road length has been sanctioned and 4,817 km road length has been completed under RCPLWEA.

(c) & (d) Since inception till 15.03.2022, the details of works sanctioned, completed and balance under various interventions/ verticals of PMGSY in Palamu & Garhwa districts of Jharkhand are as under:-

- (f) & (g) Currently 4 interventions/ verticals of PMGSY, namely, PMGSY-I, II, III & RCPLWEA are in operation. The timeline for completion of PMGSY-I & II is September, 2022, whereas it is March, 2023 for RCPLWEA and March, 2025 for PMGSY-III. Thus, as of now, there is substantial work to be completed under PMGSY.
- @ Balance road length is less than the difference of sanctioned and completed length due to reduction in road length, change in alignment, construction of part length by other agencies, etc.
