#### PLI FOR SPECS

#### 3242 SHRI DIBYENDU ADHIKARI:

Will the Minister of ELECTRONICS AND INFORMATION TECHNOLOGY be pleased to state:

- (a) the details of the number of applications received by the Union Government under the Production Linked Incentives (PLI), scheme for promotion of manufacturing of Electronic Components and Semiconductors (SPECS) and modified Electronic Manufacturing Clusters (EMC) 2.0 schemes respectively;
- (b) whether Government has given any approval to any of the aforesaid applications; and
- (c) if so, the details thereof and the amount disbursed thereunder, scheme-wise; and
- (d) the details of amount of investment expected to be brought in and employment expected to be generated because of these incentives in the electronics sector?

#### **ANSWER**

### MINISTER OF STATE FOR ELECTRONICS AND INFORMATION TECHNOLOGY (SHRI RAJEEV CHANDRASEKHAR)

(a), (b) and (c):Government has taken strategic steps and initiatives to expand the electronics manufacturing sector in the country and make India a global electronics manufacturing and design hub. As a result of various initiatives taken by the Government, several proposals have been received from investors under the following schemes:

#### PLI Scheme:-

- (i) Under the Production Linked Incentive Scheme (**PLI**) for Large Scale Electronics Manufacturing notified on 1<sup>st</sup> April, 2020, a total of 16 applications from companies have been approved. No disbursement has been made under this scheme so far.
- (ii) After the success of the First Round of PLI Scheme in attracting investments in mobile phone and electronic component manufacturing, **Second Round of the PLI Scheme** for Large Scale Electronics Manufacturing was launched on 11.03.2021 for incentivizing Electronic Components. 16 component manufacturers were approved under the second round. No disbursement has been made under this scheme till date as no claims have been received.
- (iii) Under the **Production Linked Incentive Scheme (PLI) for IT Hardware** notified on 03<sup>rd</sup> March, 2021, a total of 14 applications have been approved. No disbursement has been made under this scheme till date as no claims have been received.

#### **SPECS Scheme:-**

Scheme for Promotion of Manufacturing of Electronic Components and Semiconductors (SPECS) notified on April 01, 2020 provides financial incentive of 25% on capital expenditure for the identified list of electronic goods that comprise downstream value chain of electronic products, i.e., electronic components, semiconductor / display fabrication units, ATMP units, specialized sub-assemblies and capital goods for manufacture of aforesaid goods. The scheme is open to receive applications till 31.03.2023.

As on February 28, 2022, twenty-three (23) applications have been received and approved under the scheme and disbursement INR 50 crore is under processagainst the claim received from some of these applicants.

#### EMC 2.0 Scheme

Modified Electronics Manufacturing Clusters (EMC 2.0) Scheme notified on 1st April, 2020 provides support for creation of world class infrastructure along with common facilities and amenities, including Ready Built Factory (RBF) sheds / Plug and Play facilities for attracting major global electronics manufacturers along with their supply chain to set up units in the country. The Scheme provides financial assistance for setting up of both Electronics Manufacturing Clusters and Common Facility Centres (CFCs).

Under the scheme, 5 EMC applications have been received, out of which 2 EMC applications have been approved with project cost of Rs. 1410.84 crore including central financial assistance of Rs. 681.04 crore. As of now, financial assistance of Rs. 204.31 crore has been released.
