REVIVAL OF TEXTILE MILLS

(a) the details of operational and non-operational textile mills in the States of Tamil Nadu and Maharashtra;

(b) whether several textile mills are lying inoperative/ closed due to Covid-19 pandemic and if so, the details thereof and the steps taken by the Government to revive such textile mills;

(c) the steps taken by the Government to modernize textile mills alongwith the action plan formulated for the said purpose and the amount incurred during the last three years and the current year;

(d) whether the Government is implementing schemes to support the Textile Industry and if so, the details thereof; and

(e) the other steps taken by the Government to boost textile sector and increase its production?

ANSWER वस्त्र राज्य मंत्री (**श्रीमती दर्शना जरदोश**) THE MINISTER OF STATE FOR TEXTILES (SMT. DARSHANA JARDOSH)

(a): Based on the periodical statistical returns submitted by textile entities to the Office of Textile Commissioner, Ministry of Textiles, Mumbai, the number of working and closed spinning mills in the State of Tamil Nadu and Maharashtra are as follows:

(b): Ministry of Textiles does not have any information regarding private textile mills which are lying inoperative/closed due to Covid-19 pandemic. However, production activity in 23 working mills of National Textile Corporation were suspended due to Covid-19 pandemic and nationwide lockdown imposed by the various State Governments from March, 2020. From January, 2021 onwards, normal operations were resumed in some of the NTC mills but could not be continued due to unavailability of working capital and other financial constraints. In light of continued poor economic viability of NTC mills, Ministry of Textiles is preparing an action plan for way forward in this matter in consultation with NITI Aayog and Department of Public Enterprises under Ministry of Finance.

(c) to (e): There is no specific scheme for the revival of the closed and sick spinning mills across the country.

Government is focusing on fresh investment by industry in this sector for expansion of competitive manufacturing capacity. To this objective Govt. is implementing Amended Technology Up-gradation Scheme (ATUFS), Integrated Processing Development Scheme (IPDS), Scheme for Integrated Textile Park (SITP) and other Schemes like National Technical Textile Mission (NTTM). Government has launched Production Linked Incentive Scheme for textiles (PLI for Textiles) for Man Made Fibre, Apparel, Fabrics and Technical Textiles. It is expected to attract investment of Rs. 19000 Crore. Government has also launched PM- MITRA Park Scheme to set up 7 Mega Textiles Manufacturing Parks in the country. This will reduce logistics cost and will improve Competitiveness of Indian textile manufacturing. Once completed one such park is expected to provide employment to 1 lakh persons directly and 2 lakh persons indirectly.
